The area of social sciences and humanities described in the National Qualification Framework for Tertiary Education, determined by the regulations published on the basis of article 9 section 1 point 2 of the act dated July 27th, 2005

International relations, as an areas of studies, falls within the educational area of the social sciences and humanities. Learning about international relations as a field of research, knowledge and education concerning a range of international phenomena and processes is interdisciplinary in nature. It explores a variety of aspects of international affairs that are of interest to social sciences, including political, socioeconomic and normative aspects, as well as those of interest to the humanities, including philosophical, historical and ethical aspects. It analyses the functioning of institutions (such as states, economies and international organisations) in the international sphere, but also concerns itself with the values embodied by these relations and the culture of international affairs.

3. Connection of the course to the UwB mission and strategy:

Academics teaching the subjects included in the programme of studies will actively participate in high-level scientific research.

Teaching within the international relations programme will be in compliance with the Bologna Process.

The courses taught as the University of Bialystok as part of the international relations programme will serve to prepare the students to become organisers and leaders in international relations, including with our nearest neighbours such as Lithuania, Byelorussia and Ukraine. The studies programme will include content exploring the multicultural nature of the Podlasie region and its historical connections, which will serve to build space for tolerance and cooperation between national and religious groups. As part of the studies, the students will engage in scientific discussion that respects differing views and the dignity of others.

International relations is a modern interdisciplinary area of studies that makes the University's educational offer more attractive.

Studies undertaken in this area serve to prepare the future staff of institutions dealing with international cooperation, including in the area of the new economy, and prepare for public roles.

4. Overall educational goals as well as the potential employment and continuing education of graduates:

The goal of the programme is to provide education concerning a range of various international phenomena and processes. The programme is interdisciplinary in character with the students familiarizing themselves with a variety of political, socioeconomic, normative, philosophical, historical and ethical aspects international affairs. Apart from general subjects such as philosophy, sociology, computing and two foreign languages, the students will also gather knowledge regarding international political, economic and cultural relations as well as regarding economics, world religions and international law. Graduates will be able to seek employment in institutions and companies maintaining foreign contacts and dealing with international cooperation in political, economic or cultural areas, with particular focus on entities active in the region.

5. Indication whether the opinions of interested parties, including students graduates and employers were taken into account while defining the teaching outcomes and determining the programme of studies:

The programme project and the proposed teaching outcomes were consulted with the student body represented by the student council as well as student representatives on the Faculty board as well as with selected potential employers: national minority organisations, bodies that promote multiculturalism, the local media and firms active in foreign markets.

6. Prerequisites (abilities requires of candidates – particularly in the event of the second cycle degree):

A range of competencies in line with the teaching outcomes of the first cycle degree in international relations. Graduates of other degrees who have not obtained such teaching outcomes are to obtain them as part of supplementary units during the second cycle degree.
