IV. CONDITIONS OF GRADUATION AND CONFERRED PROFESSIONAL TITLE

A student who obtained 120 ECTS by completing the study program provided for the field of study is allowed to defend his diploma thesis on the condition that: (1) obtain two positive reviews of his diploma thesis in the APD system; (2) submitting to the Dean's office the date of the required documents, including: the paper version of the dissertation accepted by the Promoter - printed from a file placed in the APD, photos for the diploma, payment for issuing the diploma, circulation card.

Examination procedure: the exam consists of two parts as part of the final exam. In the first part, the student presents the research problem, the purpose of the work, the applied research methods and research results, and answers the Commission's question about the work. In the second part of the exam, the student draws 2 questions from two sets of questions (A set of directional questions and a set of specialty questions). During the exam the Commission can formulate additional questions.

The Commission issues a grade for each part of the diploma examination. The result of the examination is determined by the Commission based on the grades received from each part of the exam. A graduate of the second-cycle studies in the field of International Economic Relations will receive a Master's degree.
